Abstract: This collection is the record of Indiana University South Bend's Office of Research material. Included is administrative grant information of various IU South Bend departments as well as information on faculty whom have been awarded the office's IU South Bend Distinguished Research Award. The Distinguished Research Award recognizes exemplary research, publications, and dedicated involvement and gives the award to IU South Bend faculty and administrators according to certain qualifications. Some of these qualifications include: a minimum of eight years of research experience in the faculty member's discipline, significant contribution in the faculty's discipline, significant publications or other means of dissemination, and exemplary reputation as a researcher/scholar/leader in the faculty's discipline. Scope and Content Note: This collection documents the research, publication, and service of Indiana University South Bend faculty through the years and their involvement with the campus' Office of Research. Furthermore, this collection also includes documents pertaining to the IU South Bend *Administrative Digest* of 1976, which contains various types of administrative grant information requested by multiple IU South Bend academic departments. These grants are designed to assist in research and/or projects that will benefit the particular academic department at IU South Bend.

The documents within this collection date from 1976 to 2012 and are organized in chronological order (with the exception of the Administrative Digest of which is organized alphabetically according to department). The folders within Box 1 of this collection contain administrative information of several different IU South Bend departments (e.g. Arts & Sciences); in particular, approvals of grants and project as well as their cost and duration. The folders within Boxes 2 and 3 of this collection contain information from various different IU South Bend professors such as Deans' letters, curriculum vitae, and letters of recommendation, book chapters, award certificates, and articles in order to be considered for IU South Bend's distinguished Research Award.
